# **Directors Update**

# I. Grant updates:

# • School Construction:

\$4.2million is now available in the state portal for school construction grant management. All billing associated with eligible construction expenses will now go through the granting system.

## • FRC (Family Resource Center):

Our FRC has been restored with funding at \$100K/annually. The \$100K is in the electronic grant system but has not yet been released for drawing down.

#### • Title IV:

We have received \$10K for our technology transition plan.

#### • Private Donation:

We received a \$30K donation in December 2017 for the hardware component to our technology transition plan

# II. Staffing Update:

Meredith Holod has been hired as the Grade 3 long-term substitute teacher while Kristie Guvremont is on leave. Kristie's leave is expected to end in April 2018. Meredith is a CT certified teacher who most recently worked as a 1 year+ substitute at Naramke elementary in Norwalk. She has experience in both regular ed and special ed classrooms.

## **Building Report**

Construction of Annex building is on schedule. Could possibly be completed earlier than schedule. The question of solar panels was brought up and committee reported they had previously been investigated and determined no net worth.

Proposed signage of building has been distributed to necessary City departments.

## **Finance Committee**

Adam reports that all is going smoothly, no surprises.

Liability account #2501 Annex Loan change increased \$700K for the purpose of paying expenditures for construction.

On the P & L

4050 CT Allocation \$50K unfavorable - 1 student shy so allocation at year end will be \$11K shy.
4110 Special Education reimbursement \$41K to date but solely a timing issue.
6200A Health Insurance - favorable to budget as new hires have not taken insurance
6400B4 No oil deliveries until December, and then large in January so favorable posting will go away.
6400 ground repair - unfavorable - yard worked from construction that cannot be paid for with building grant.

Next meeting schedule for 2/8 where PTCO will discuss plans for a Spring Fundraiser.
