A. Directors update

I. Staffing:

- a. Kristie Dorfman hired as newest member of SBS faculty. Applications and resumes from 70+ applicants were screened; 16 of those applicants were selected for interviews, and eventually 3 finalists gave demo lessons. In the end, Kristie Dorfman was the consensus pick from the committee. Kristie will begin the 2015-16 school year as the 2nd grade teacher at Side by Side.
- b. Current vacancies: (positions posted for hire; summer)
 - 3rd grade classroom Teaching Assistant/Sped Aide
 - US Mathematics Teaching Assistant
 - US Science Teaching Assistant

II. Facility Projects update:

- a. Paving project:
 - Contract signed with Piro, Inc.;
 - Cost: \$155,000; (grant budget= \$170,500)
 - Grant will cover \$124K; SBS=\$31K;
 - 10% deposit of \$15500 paid on 5/19.
 - **Project start June 29, 2015**
- b. New Boiler project:
 - Contract signed on 6/11 with Devine Brothers, Inc.
 - Cost: \$109,500 (grant budget= \$126,625)
 - Grant will cover \$87,600; SBS=\$21,900
 - \$43K deposit paid on 6/11/15
 - **Project start June 29, 2015**
- c. Bathroom Renovations
 - Contract will be executed on 6/17/15 with JBC Construction, Inc.
 - Cost: \$160K (grant budget=\$162,800)
 - Upgrades from original plan include auto sensors for all toilets, sinks and urinals; anti-graffiti paint
 - **Project Start: June 22, 2015**
- d. Network Cabling/rewiring
 - Project to begin in July
