Directors update

I. Enrollment: Our official enrollment for FY2017 is 236. (10/1/16 snapshot). This is accurate to budget (\$2,596,000)

II. SBS Charter Renewal:

- Took place as scheduled on 10/19

- Mostly positive feedback during visit
- Formal written feedback is forthcoming; anticipating that there will be required need for documented policies and procedures in the area of financial controls; separation of duties; BOD financial oversight
- Follow-up visit from CT Chief Turnaround Officer Desi Nesmith scheduled for Wed. 10/26
- Immediate required changes based on Charter Renewal Visit:
 1. BOD policy for Nepotism and Conflict of interest must incorporate recommended changes from CSDE
 2. BOD By-Laws and SBS Board make-up may not include a voting member seat designated for any SBS employee other than a certified teacher (as per CT Gen. Statute). No Paraprofessional, Teaching Assistant, or Administrator can occupy a voting seat on the SBS Board.

III. Health insurance:

- Approaching our renewal 12/1/16
- Premium increases projected to be flat or potentially a slight decrease.
- This is a pick-up to budget projection for FY17 (+18%)
- Due to the less than budgeted increase, proposed plan offerings will remain similar to current; two plan offerings: HSA and HRA structured similarly to current plans (50% of deductible is provided on quarterly basis to those electing HSA; 50% deductible reimbursement for HRA – employee responsible for first half, employer for second half)
- Continued composite rate offerings
- Employee contribution rate towards premium remains at 16%

Immediately following Directors report Kim motioned to adopt new language on BOD by laws to include nepotism and conflict of interest clause and elimination of non-certified teacher board seat as requested by CSDE. Motion second by Steven. Added to next month's agenda.
